Memorandum of Understanding

This memorandum of understanding is made and entered into on 26/10/2018 between Young Indians (hereinafter referred as Yi) and Nirmala College Muvattupuzha.

And Whereas

It has over 2600 direct members in 40 city chapters, and indirect membership of 8500 through its Yuva. And Whereas

The Yi Yuva platform is one of the most active focus areas within Young Indians by which Yi members engage students from across the country in various initiatives that the students conceptualize, plan and execute. It is hereby mutually agreed to by both parties as follows

The role of Yi will be to nominate a member from within its membership (called as Yuva Chair) who will be a mentor to the Yuva.

This Agreement will be in force for an initial period of one year and may be extended for further periods before the expiry of this Agreement.

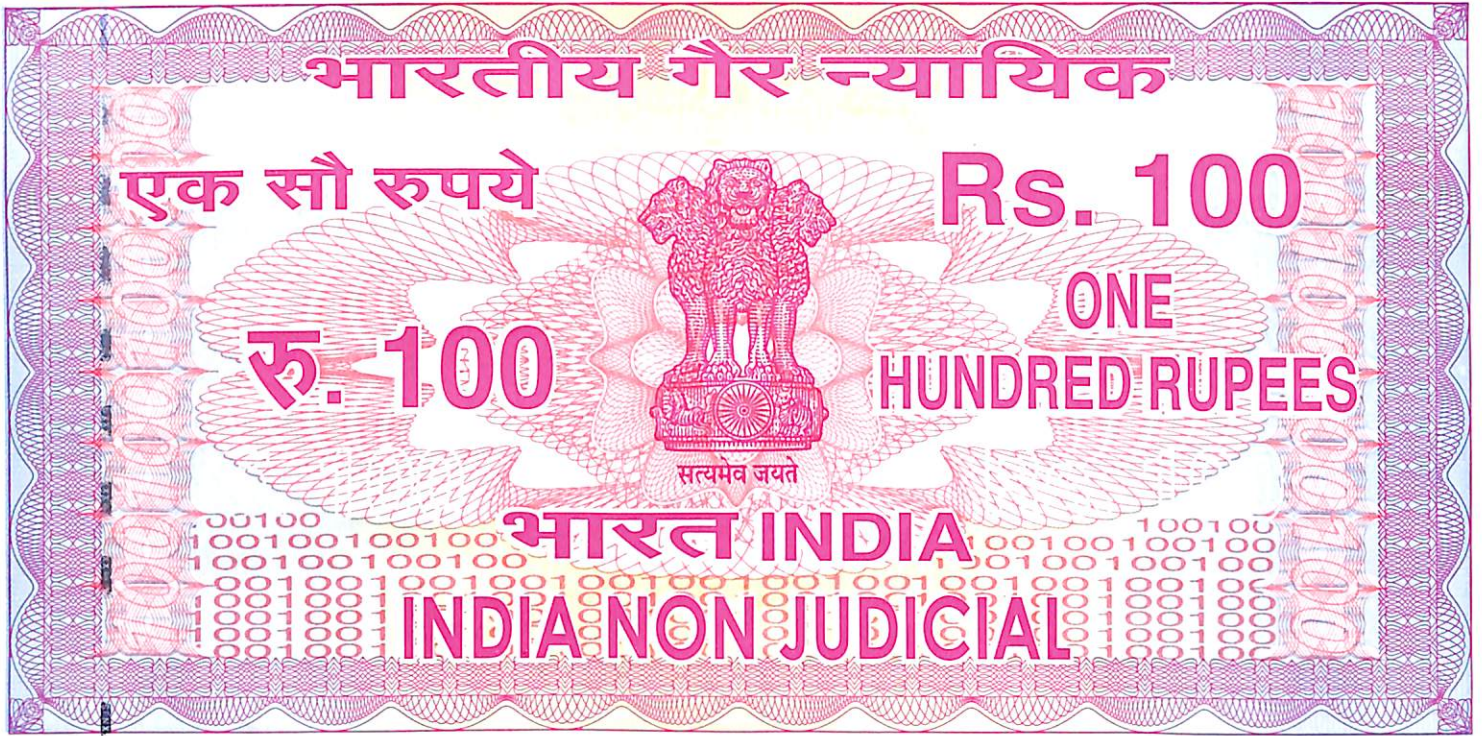

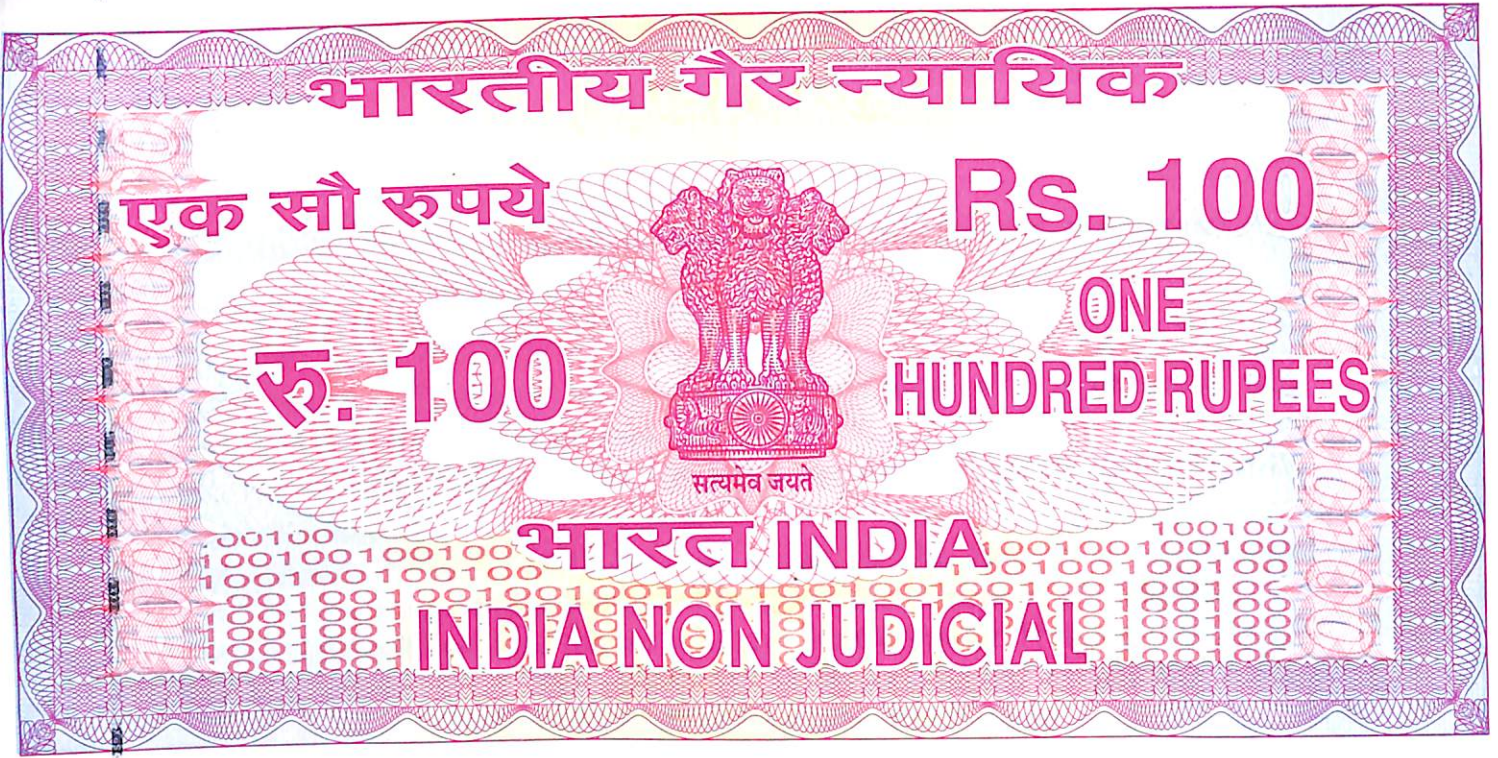

Now these presents WITNESSETH and the parties herein consent as follows:

Article II

1. The Chapter undertakes to provide the technical advice on rules and regulations of ICAI Examination.
2. The Chapter undertakes to send students registration reports and returns to Head Office.
3. The Centre (College) will have to abide by the rules and regulations described in the prospectus and will be under the control of the Chapter.
4. The Chapter will provide question papers for Computer Training (100 Hrs.) and assessment tests. The exams are to be conducted as per the rules, directions and specifications of this Chapter by the College
5. The Chapter will issue eligibility certificate to the students on the basis of the criteria of the Institute.

Article III

1. The College shall provide Class rooms with all facilities for the conduct of classes.
2. The College shall provide the necessary stationery for conducting classes.
3. The College shall ensure that sufficient staff are available at the time of the admission to the course.
4. The College shall undertake to create awareness among to the students in and around the locality for joining this course and provide facility for conducting Career Guidance Course.
5. The College shall provide facilities to conduct interview and computer classes.
6. The Faculty for the centre shall be selected jointly by the Chapter and the College from the faculty of the college and from the industry based on the eligibility criteria prescribed by the ICAI Head Office.
7. The College undertakes to appoint a coordinator to interact with the officials of the Chapter & manage the day to day affairs of the centre.
8. The College shall maintain the records of attendance of students and faculty and these records would be subject to periodical inspection.
9. The College shall provide computer lab facilities for the prescribed computer training to each student.
10. College shall maintain all the accounts for verification and inspection by the Chapter Officials and Auditor.
11. The students can remit their fees through local branches of Punjab National Bank and IDBI Bank.

12. The Centre shall abide by and follow the other rules and regulations given in the prospectus of the Head Office a copy of which is appended herewith.
13. The students possessing the Institute's identity card shall be permitted to use the library facilities of the College as per the terms and norms of the College.
14. The College through its principal in which the students are undergoing the Course shall issue documentary evidence on attendance, assessment marks, and participation in Communications and Soft Skill seminars, factory visits, assignments and completion of 100 hours of computer training of the course to the Chapter.

Article IV

Fees: (1) The students can pay their fees through the Challan of Punjab National Bank / IDBI Bank.

Registration fee:

Foundation Rs 4000/- and Intermediate Rs 20,000/-

(Fees are subject to the change from time to time as per HO Council decisions)

Finance: The chapter will not provide any financial support/compensation to the college on any account except the following.

- 1) Coaching Fee- Foundation Rs. **2,500/-** (Rupees Two thousand Five hundred only) per student and Rs.**8,000/-** (Rupees Eight thousand only) per student for Intermediate.
- 2) Conducting of 100 Hrs. Computer training for Intermediate students at your end and Computer assessment examination question papers will be provided by the Chapter.
- (3) Trainer for the 3 days Communication and Soft Skill training will provide by the Chapter and other expenses like refreshments will borne by the College.

Article V

1. This MOU shall enter into force upon signature by both parties and remains in force for a **period of three (3) years**, unless terminated earlier by either party upon ninety (90) days, with a written notice to the other party. All the terms and conditions as shown in this MOU shall be binding upon the



The chapter reserves the right to terminate the contract immediately for any violations of the rules and regulations of the Head Office or the violations of the terms and conditions contained in this MOU.
2. This MoU will be automatically terminate if any career guidance programme is conducted within the radius of 20 Kms. of any Five chapters in the Kerala Circle (Cochin, Kottayam, Palakkad, Thrissur and Trivandrum), Support centers and Satellite centers of the Institute of Cost Accountants of India, Kolkata.

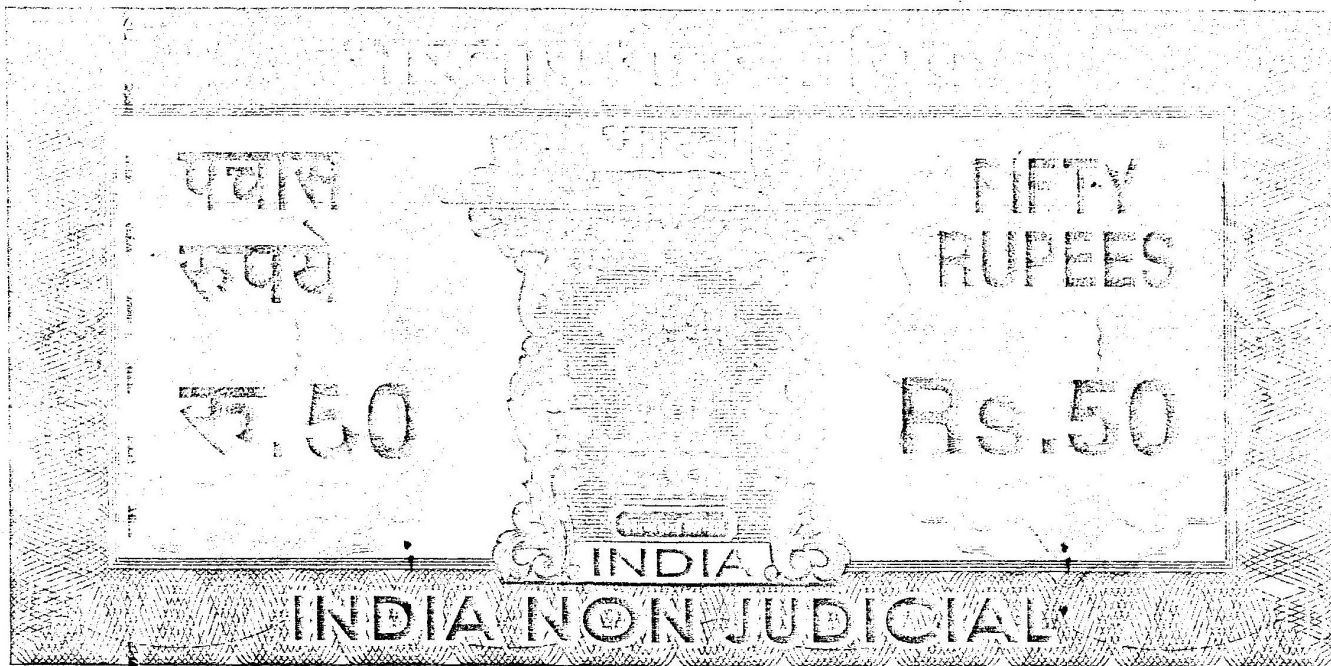

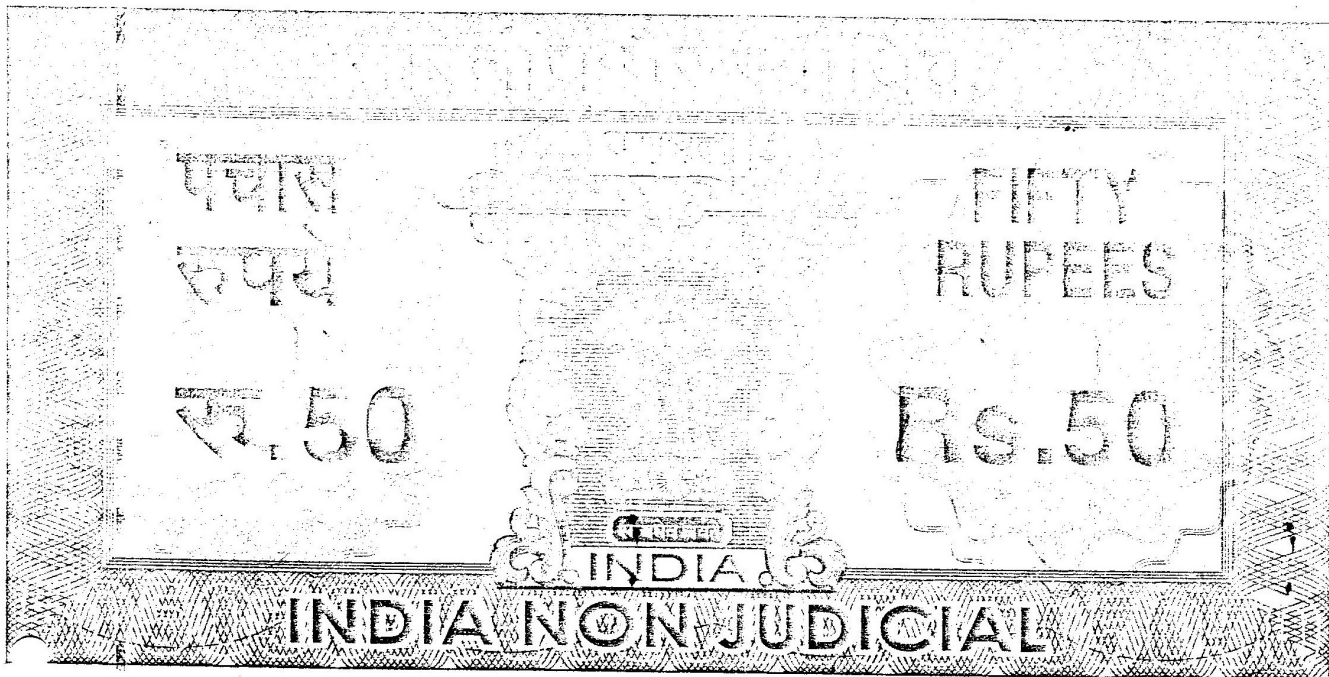

1.6 'FINANCIAL YEAR' means a period of three hundred and sixty five (365) consecutive days or three hundred and sixty six (366) consecutive days when such period includes a twenty ninth (29th) day of February, beginning at 0800 hours from first April.

1.7 The headings of or titles to the clauses in this AGREEMENT shall not be deemed to be part hereof or be taken into consideration in the interpretation or construction thereof or of the AGREEMENT.

1.8 Words imparting the singular only also include the plural and vice versa, where the context so requires.

1.9 The present agreement is entered in to by KEIL for collection, storage, treatment and disposal of Hazardous waste of its members.

2. **PERIOD OF AGREEMENT :**

2.1 The present Agreement shall come into force from the date it is signed or the date when KEIL is able and prepared to send Transportation Vehicles / Transportation Vehicles to the Member, whichever is later and that the present Agreement shall remain in force for a period of 5 (five) years, effective from any of the above named dates, whichever is applicable.

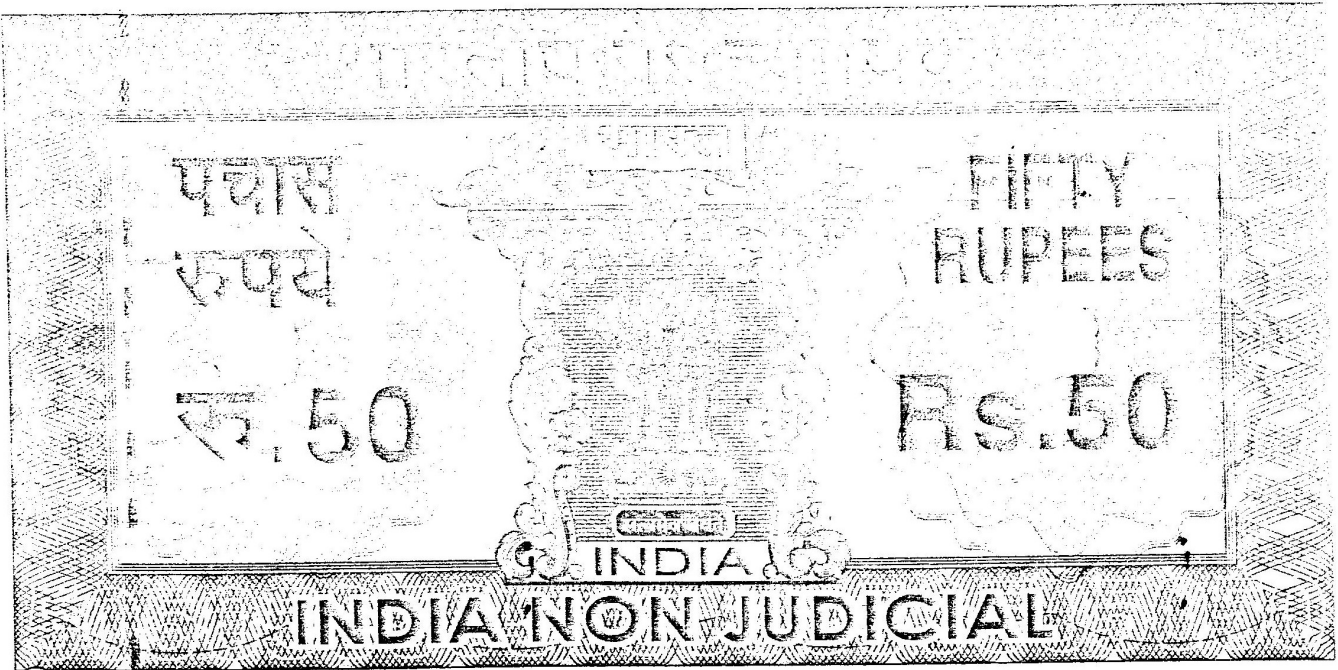

3. EXTENSION PERIOD OF AGREEMENT


3.1 If the Member wishes to send its Hazardous Waste after the expiry of the present Agreement, it shall give four (4) months advance notice to KEIL of its desire of extended period of facility and KEIL shall consider the request and may, in its absolute discretion, offer terms for the fresh agreement.

Both the parties hereto, after reaching an agreement on the offered terms, shall execute a fresh agreement at least three (3) months before the date of expiry of this agreement.


3.2 Both the parties hereto agree that the present Agreement shall automatically come to an end in any of the following eventualities:

- I) On expiry of Authorization granted to the Member and the same having not been renewed or the same having been not granted by KS-PCB.
- II) On expiry of the present Agreement, where no fresh agreement is signed and executed between parties hereto as mentioned above.
- III) On Authorization to KEIL being cancelled, refused or not granted by KS-PCB.

3.3. Both the parties hereto further agree that in case of the present Agreement coming to an end owing to any of the aforesaid eventuality, it will be the sole responsibility of the Member to handle and treat its Hazardous Waste in accordance with the relevant provisions of law and that KEIL will not be responsible in any manner whatsoever in respect of the Hazardous Waste of the Members.

4. OBLIGATION OF THE MEMBERS:

4.1. While entering into the present Agreement with KEIL, MEMBER shall submit the categories of Hazardous Waste and its desire to dispose off the same and that the said categories of Hazardous Waste shall be as per those specified in the Schedule to Hazardous Waste (Management, Handling & Transboundary movement) Rules 2008 as amended from time to time. The Member shall also give true and correct information related to the description, amount, nature and toxicity of the said Hazardous Waste as and when called upon by KEIL or KS-PCB.

4.2. The MEMBER shall get the Authorization from KS-PCB permitting the Member to send its Hazardous Waste to KEIL for disposal and that it shall be the responsibility of the Member to get the same renewed from time to time, failing which KEIL reserves its right to repudiate the present Agreement.

4.3. For direct disposal of the toxic / hazardous wastes in the landfill, the Member shall ensure that the waste is free of toxic materials / heavy metals or Phenols, Cyanides and the waste should meet the accepted criteria for the land filling.

4.4. The waste which cannot be accepted for direct land filling will be subject to required treatment like neutralization, solidification, Stabilization or any other chemical treatment. Based on the requirement and depending on the waste characteristic, KEIL will decide the treatment. Member has to bear the treatment cost. The treated waste in such case can be disposed off in the landfill.

4.5. The waste should be kept in the containers specially designed for the transportation of hazardous waste.

4.6. The MEMBER shall make all the proper and adequate arrangements for keeping accurate records of production and shall keep accurate records of production of each of its products and Hazardous Waste generated thereof and send the compiled records to KEIL on the fifth (5) day of the succeeding MONTH, whereupon the KEIL shall send the same to KS-PCB.

4.7. MEMBER shall be required to maintain the record of Hazardous waste to be disposed off in KEIL site. The said records so maintained shall be open for inspection by KEIL or any officer of KS-PCB or any authority of State (Ministry of Environment and Forests) or any officer appointed by them.

4.8. The MEMBER shall make adequate and necessary arrangements as approved by and to the satisfaction of the KEIL, KS-PCB or other prescribed Authority under Law for collection and storage of its Hazardous Waste in its premises and shall give access to the Transportation Vehicles / Transportation Vehicles of KEIL to its storage facility during day time.

4.9. Before the Hazardous Waste is delivered at KEIL site, the Member shall ensure that the said Hazardous Waste is packed and transported in a manner suitable for transportation and that the Member should see that the said waste withstands physical and climatic conditions.

4.10. If and when an accident occurs during the handling / transportation of Hazardous Waste the Member availing facility shall immediately report to KEIL and KS-PCB about the accident.

4.11. The Member shall be bound to accept the rejected Hazardous Waste, if any, and if it fails to do so, his membership will be terminated.

4.12. During wet period of monsoon season, the Hazardous Waste may not be accepted. The Member shall create proper temporary storage facility which would include leachate facility or any other facility as provided or approved under the provisions of law.

4.13. The member shall create required temporary storage facility (minimum 4 months generation) considering the heavy monsoon in Kerala.

4.14. As far as possible the containers are to be filled in full. Proper arrangements have to be made for lifting the containers. It is to be ensured that once the Hook-loader reaches the factory, after collection of the wastes, it leaves the factory within one hour.

4.15. The MEMBER is obliged to intimate KEIL to send containers / hook loader and to despatch a minimum full load of Hazardous Waste within two hours.

4.16. The MEMBER is obliged to pay in advance transportation /treatment/disposal/analysis charges in cheque (local account) or demand draft.

4.17. KEIL may by a notice served on the Member require him to provide such additional information as may be specified in the notice and the member shall send the information to KEIL within 15 days from the receipt of the said notice.

4.18. The MEMBER declares that the MEMBER alone shall be liable for any action initiated against the MEMBER under Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008 or any other Pollution Laws or any other relevant provisions of Law for the time being in force, by KS-PCB or any other Authority.

4.19. The MEMBER shall comply with the provisions of Environment (Protection) Act, 1986 and the Rules made thereunder as also with the conditions of present agreement and that any breach committed thereunder shall render the Member not eligible for disposing of Hazardous Waste in KEIL.

5. QUANTITY & QUALITY

5.1. The Hazardous Waste to be sent by the MEMBER to KEIL shall be as per the categories specified in the schedule to Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008 or as per any new amendment or rules under the above Act.

5.2. The MEMBER shall not send for direct landfilling in any case any Hazardous Waste containing Hexavalent Chromium, heavy metals, phenols, cyanides or any other toxic materials in concentration as specified in the Clause 5.3 or that may be notified by KEIL from time to time. However, such wastes may be accepted for treatment and disposal with extra charges for treatment.

5.3. The following listed wastes will not be accepted by KEIL.

- i) Waste which is fluid, slurry, paste or acidic.
- ii) Waste which has an obnoxious odour.

- iii) Waste which reacts with moisture to produce considerable amount of heat or gases.
- iv) Waste which is inflammable. (except for incineration) .
- v) Waste which contains shock sensitive substances.
- vi) Waste which contains volatile substances of significant toxicity.
- vii) Waste which contains more than 10 mg / kg chromate in the original sample.
- viii) Waste which contains more than 10 mg / Kg. of Water-soluble Arsenic in a 1/10 elute.

5.4. All toxic wastes from pesticide industries shall be incinerated before sending to KEIL site. The waste shall not contain any acidity.

5.5. KEIL may reject the Hazardous Waste in total, if the MEMBER's above mentioned Hazardous Waste is found not to be in accordance with the conditions mentioned in clause -5 of this AGREEMENT and the decision of KEIL in rejecting the Hazardous Waste of the member for non-compliance of the provisions of the present clause of this Agreement will be final and it will not be called in question and the MEMBER shall have to pay the extra amount which shall be charged by KEIL for expenditure incurred in analyzing, transporting and returning the rejected Hazardous Waste.

6. TRANSPORTATION

6.1. Transport of Hazardous Waste shall be in accordance with the provisions of Rules issued by the Central Government under Motor Vehicle Act, 1988 and other guidelines issued from time to time and/or subject to the provisions of law for the time being in force.

7. BILLING AND PAYMENT OF DISPOSAL CHARGES.

7.1. The sample of the Hazardous waste will be drawn from the supply and will be got analysed by KEIL Laboratory or Laboratory approved by KEIL. The charges for analysis will be borne by the respective member.

7.2. The MEMBER shall pay to KEIL the charges for disposing of its Hazardous Waste as may be notified by KEIL by cheque or Demand Draft in advance.

7.3. KEIL shall charge the MEMBER on the basis of weightment to be done at disposal site. If the Weigh Bridge at disposal site is not working, it will be weighed at outside weigh Bridge approved by KEIL.

7.4. The MEMBER shall be bound by the analysis results / reports of KEIL for treatment and disposal charges and shall not call the same in question for any reason whatsoever.

8. DEFAULT

8.1. If the MEMBER fails and / or defaults in the discharge of any of his obligations under the present Agreement, KEIL shall have discretion to (i) refuse to accept the Hazardous Waste of the MEMBER for disposal without assigning any reason. (ii) notify to the KS-PCB the name of the Member informing about such default and that its Hazardous Waste would not be taken for disposal by KEIL on account of such default, (iii) inform the Member that its Hazardous Waste would be deemed to cause pollution and that the Member be liable as polluter under the Pollution Laws.

8.2. KEIL reserves its right to accept or refuse membership. In event of MEMBER committing any breach / violation of the conditions of the present Agreement or any provisions of PANCAJAL Rules

for the time being in force. KEIL reserves its right to suspend / cancel the membership for such period as it deems fit without giving any reasons or prior notice.

8.3. Where an offense under the Environment Protection Act has been committed by the Member or is attributable to any neglect on the part of the Member which shall include its Director, Manager, Secretary, Officer, Partner, etc. and if such Member is guilty of the offense or is liable to be prosecuted against and punished and no suit, prosecution or legal proceeding(s) shall lie against KEIL for the offense committed by its Member.

8.4. KEIL reserves its right to issue a show cause notice to the Member if it is of the opinion that the Member has contravened the provisions of law / conditions of the present Agreement, requiring the Member to remedy the contravention or as the cause may be, within a specific period of time. The said notice served shall specify the measures to be taken by the Member in remedying the said contravention.

8.5. KEIL shall inform the Kerala State Pollution Control Board / KSIDC of the suspension of any MEMBER.

8.6. The suspension / termination shall be revoked only at sole discretion of KEIL after it is satisfied that its conditions have been met.

9. TRANSFER OF RIGHTS


9.1. KEIL may at any time transfer or assign its rights and obligations under the AGREEMENT to any other company or business concern by giving notice in writing to the MEMBER. Upon such transfer or assignment, only the transferee or assignee shall be liable for the obligations herein contained.


10. INDEMNITIES :

12. Any change in the terms and conditions of MoU should be effected only through mutual understanding of all the parties. Such understanding shall always be in writing, signed by all parties.
13. Subject to earlier termination as hereinafter provided the term of the Memorandum of Understanding here under (the "TERM") shall, commence on the date hereof, and shall stand terminated after 36 months from the date of commencement of this MOU.
14. **VALIDITY OF THE MOU:** The validity of MOU shall be initially for a period of 02 (Two) years from the date of signing which may be extended for such periods and terms and conditions as mutually agreed upon by all the parties.

15. SETTLEMENT OF DISPUTES

In case of any dispute/difference of opinions in respect of any of the above clauses including its interpretation thereof, the matter will be submitted for a decision of a committee comprising of the Director of Academic Training Partner, Principal/Manager of Facilitation Support Partner and Managing Director of NSDC Training Partner. The decision of the committee on any or all of the matters thereof shall be final and binding on all the parties. But if the dispute is not settled within 30 days, the dispute shall be referred for arbitration as per Arbitration & Conciliation Act 1996. The court at Thiruvananthapuram alone shall have jurisdiction over the subject matter of this MoU

16. FORCE MAJEURE

If any party shall be considered defaulting in performance of their obligations under the terms listed in this agreement, if such performance is prevented or delayed for any cause beyond the responsible control of the party affected such as war, natural calamities, hostilities, riots, fire, explosion, flood, earth quake or because of any law or other proclamations, regulations or ordinance of any Government or sub division thereof or any other cause beyond the control of the concerned training partner which could not have been foreseen or avoided by the exercise of due diligence, provided, notices of any such cause with necessary evidence is given within a 14 day period of its occurrence or if this

3. The Second Party agrees to send a weekly progress on the number of palms surveyed, data collected and pending samples to be covered under the survey.
4. The Second Party agrees to scrutinize the data collected and to make data entry in the online software provided by the Board, compile, analyze the survey data and estimate the yield per palm, per hectare and estimate the coconut production block wise and aggregated estimate for the district for the year 2016-17 and submit the detailed report covering all the information to the First Party, within 20 days after completion of the survey

a. First installment : - Sanctioned fund under the following heads



'Course' IAS preparatory classes offered by ALS.

'Intellectual Property Rights' includes intellectual property rights associated with the Marks owned by the Franchisor including patents, trademarks, trade names, copyrights, processes and designs in Course contents and materials prepared by the Franchisor (whether registered or not).

'Tele-education Program' means the Courses offered by the Franchisor through Telecommunication facilities wherein the courses will be conducted by the faculty members of ALS in Central Studios and shall be delivered to students in the FRANCHISE CENTRE(s).

'Assigned Area' means the area within municipal limits of the Franchise Centre.

2. RIGHT TO RUN FRANCHISE

- (g) The Franchise Centre shall be prepared by the franchisee as per standard design provided by the Franchisor in due compliance of law in force relating to running of the said franchisee centre including all health, occupational and other safety norms, as may be prescribed from time to time by the statutes, government authorities and bodies, while carrying out the operation of the FRANCHISE CENTRE and to have valid insurance during the validity of this agreement or any renewal thereto, against all risks and third party insurance against all possible liabilities including the misshaping with employees and students;
- (h) The Franchisee accepts that there will be no relocation of the Franchise Centre by the Franchisee without written permission by franchisor.

- (j) The Franchisee shall not permit unauthorised students attend the Course;
- (k) It is agreed by the franchisor that in furtherance of the functioning of franchisee centre all cost of study material including books, notes, photocopy expense of assessments/test series shall be borne by ALS.
- (l) Franchisee acknowledges and accepts that the Franchisor's representatives shall have the right to enter the Franchise Centre during business hours to examine the Franchise Centre and to notify any deficiency, unsatisfactory condition or non-compliance, which shall promptly be cured by franchisee.
- (m) That the Franchisee agree and confirm that the classes/coaching as provided by ALS are student centric and not faculty centric, the franchisor has full right to change the faculty for any subject, even during the continuance of the batch for which the student has enrolled with ALS. The Franchisee by signing this instant Agreement unconditionally agree and confirm that the terms of this Agreement shall supersede all/any oral assurance/s as given to Franchisee and any oral/written assurance/s, by any one be that it be the representative of ALS or Franchisee, which is in contradiction with the terms of this Agreement, shall be null and void.

- (b) To advertise and promote the Franchise Business through common trainings, promotions, contests, events etc;
- (c) To comply the directions pertaining to infrastructure and equipments as prescribed by the Franchisor including the hiring of Centre Counsellor, Class Co-ordinator, Centre Manager/Business Development Executive as mandatory staffing requirements at the centre at the cost and expenses of the Franchisor;



• **Whereas Spices Board shall**

1. Provide/make arrangements for quality planting materials/ saplings of major spices, which can be planted in the said location.
2. Provide necessary technical guidance on planting: prescribe good agricultural practices for the plants and the scientific nomenclature and details of the spices.
3. Provide a financial assistance of Rs. One lakh towards expenses for setting up the Sugandhawadi. The amount will be released to the selected institutions as two installments of Rs. 50,000/- each, first installment after executing the MoU and second installment after successful establishment of the Sugandhawadi and inspection by the Spices Board.
4. Review the status of establishment of the Sugandhawadi, after three months of establishment and the Board will arrange for replenishment of the planting materials, if found necessary and further undertake periodic reviews of the Sugandhawadi.

b) Whereas the institution shall

1. Identify an appropriate space, within its premises and set up the Sugandhawadi, label each spice plant, manage and maintain the garden.
2. The Garden should be named as "Sugandhawadi" - established with the support of Spices Board India".
3. Encourage the students to acquaint themselves with the spices and motivate them to know more about the spice and its values and come out with articles, or new experiences, for consideration of publication in the Board's journals.
4. Total expenses in connection with the establishment and maintenance of Sugandhawadi, shall be met by the institution. The financial assistance provided by the Board shall be limited to Rs1,00,000/- (Rs One lakhs only) for establishment of Spice Garden.

5. Assign a student's club/group under an employee of the institution for managing and maintaining the garden throughout the year & send quarterly report and photographs on the status of the Sugandhawadi for the initial two years.

CIAL Learning Programme

The objective of the programme is to create a bridge, a platform for the students to work in cross functional teams with a broad objective of enhancing their leadership skills and giving back to the nation. In the process, the students work in leadership roles while operationalizing projects that

are based on self-development , skill building, community service and nation building. The programme intends to provide an opportunity to start thinking and work for India, sowing the seeds of thinking about India and its growth at schools and colleges, an invaluable motivation for young minds to see how other young achievers are making a difference, bridging potential with achievement, a unique networking opportunity with peers across the country, developing leaders for tomorrow.

Cochin International airport is the first airport in the world that completely operates on solar power. Cochin airport's solar power plant is producing 50,000 to 60,000 units of electricity per day to be consumed for all its operational functions. Students visited CIAL and learned about the Solar Power Plants. There are both roof mounted and ground mounted solar panels. Roof mounted are East-West facing solar panels and the ground mounted ones have vegetations in between them. The plant generates an average of 48000 units of electricity everyday which is utilized for running the AC power plant situated on the top of the terminal building. The plant essentially consists of 46150 solar panels of 260Wp capacity, which convert the solar energy into DC electricity. The panels are connected in series-parallel configuration to attain the desired voltage and power levels. The efficiency of the solar panel is at its maximum at 25 degrees. The guide explained in detail, the functioning of solar power plants. In localities with either no grid connectivity or intermittent grid failure, battery storage systems may be installed along with the solar plant to store the electrical energy generated during day time (6am to 6pm). The stored energy can be utilized during 'non-sunshine' hours and night. However, owing to the high capital expenditure and difficulties associated with their routine maintenance, CIAL has not employed storage systems in this plant. Instead, they utilize the 'banking' facility provided by KSEB for the renewable energy developers. In this scenario, the excess energy generated during day time can be injected into the grid and can be taken back as and when required without remitting any excess charge. Any excess units fed to the grid will be paid by the electricity board at the end of the solar calendar (October-September) as per the prevailing average pool purchase cost. This 'banking' policy enables the airport to be grid-neutral even without any battery storage system. Overall, this programme was a great experience and very informative for all the students.

REPORT OF THE FOUNDATION PROGRAM FOR THE YEAR 2018-19

Based on the MOU between Nirmala College Muvattupuzha and CMA Cochin Chapter the Research and Postgraduate Department of Commerce is running CMA programme in Nirmala College. The college is offering both foundation and intermediate programmes. Coaching is offered for the June exams each year. Admission is open for the B.Com. students of this college and the nearby colleges. Classes are normally arranged on Saturdays and other holidays. Classes are handled by experts from the college and outside the college. Registration for the foundation programme can be done through online or offline mode. Online registration can be made through the website of Institute of Cost Accountants of India (icmai.inc.in). Offline registration can be done through the college or the Cochin Chapter of ICMAI. The classes will be held at Nirmala College Muvattupuzha. 30 Students were admitted for the foundation programme during the year 2018/19. Classes were started on 22/12/2018. The classes finished on 03/6/2019. In total 100 teaching hours were provided to the students. Out of the 30 students 29 have cleared the exam which was held in June 2019.

REPORT –IDUKKI DISTRICT

Statistical Survey for the estimation of coconut production in Kerala during the year 2016-17.

In early days of migration coconut cultivation plays a significant role in the agrarian economy of Idukki district. Even though, cultivation of coconuts is widely seen in coastal areas, coconut and its various products are consumed by almost every household in Kerala. Thus the crop has gained national importance as food, oil seed, and beverage crop, they are the major source of raw material for a large number of agro-based industries. But people found that cultivation of other crops were more profitable when compared to cultivation of coconuts, so they shifted over to other crops (cardamom, pepper ,rubber etc.)) in almost all the blocks in the district. Thus over the years, it seems that the area under coconut cultivation is shrinking in the district . At present coconut cultivation occupies a low position among the major cultivation in terms of area under cultivation.

The Coconut Development Board entrusted the survey, estimation of coconut production in the district of Idukki and preparation of the report relating to the survey to the Department of Statistics, Nirmala college Muvattupuzha and a memorandum of understanding was signed by the Principal of, Nirmala college Muvattupuzha and the coconut development

board. Dr.Johny Scaria, Department of Statistics was the Principal Investigator and co-ordinator of the survey in Idukki District.

From the various blocks in the district, 7 blocks having a major share of coconut production were identified for carrying out the survey. The blocks identified were Adimali, Azutha, Elamdesam, Idukki, Kattappana, Nedumkandam and Thodupuzha,. Based on the area under coconut cultivation, one panchayat each was then selected for the study from each block. The selected panchayats were Konnathady in Adimali, Peruvanthanam in Azutha, Kodikulam in Elamdesam, Arakulam in Idukki, Upputhara in Kattapana, karunapuram in Nedumkandam, Manakkad in Thodupuzha. The field investigation was carried out by 4 young and dynamic statisticians. They were got some initial training from the coordinator. The climbers were educated youth, having previous experience and trained in climbing the trees using specially developed climbing machines and they were able to climb around 40 trees in a day. The field work took about 6 days. The data collected was entered in the computer by the investigators (Denny Sebastian, Shukkoor K.Y, Crystel Babu and Krishnakumar K.P) as per the instructions received from the Coconut Development Board. The climbers were received remuneration at the rate of Rs 40 per tree besides transportation charges. The survey started in the first week of December 2016 and was completed by the third week of December 2016.

From the selected coconut farms 10 trees were selected at random. The size of the farms selected was varying depending on the panchayat.

The number of holdings which were surveyed in each panchayat is given in a table below. The area of each block and the percentage share in area is also included in the table.

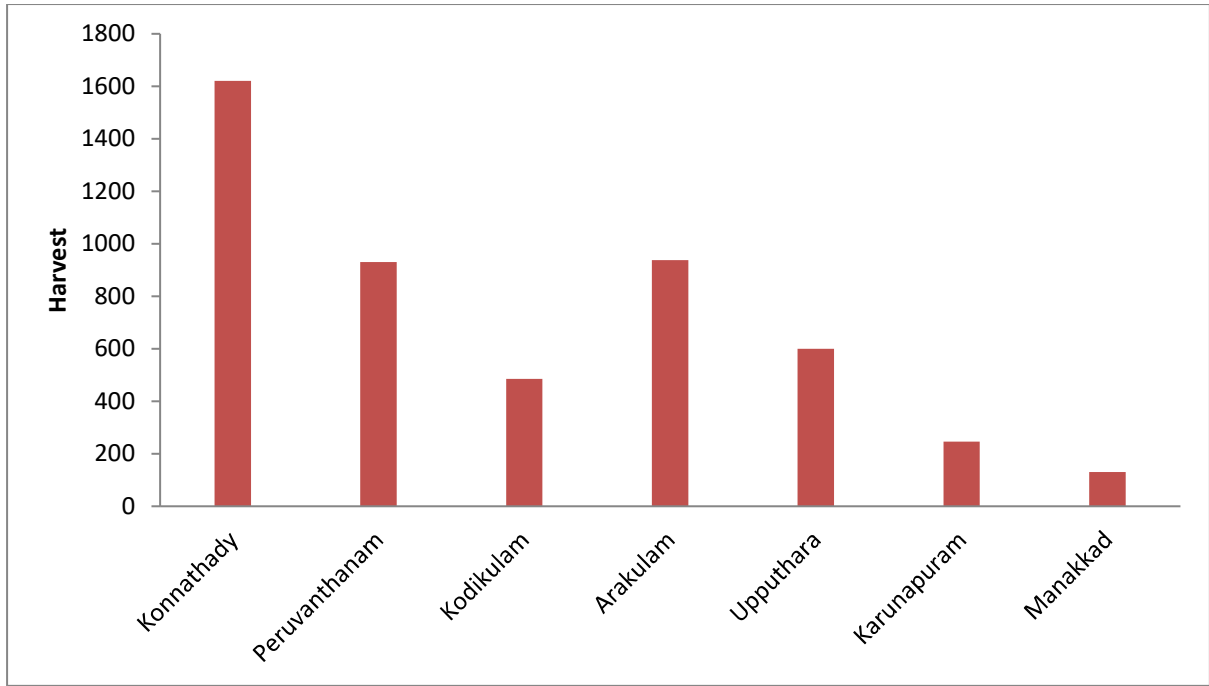

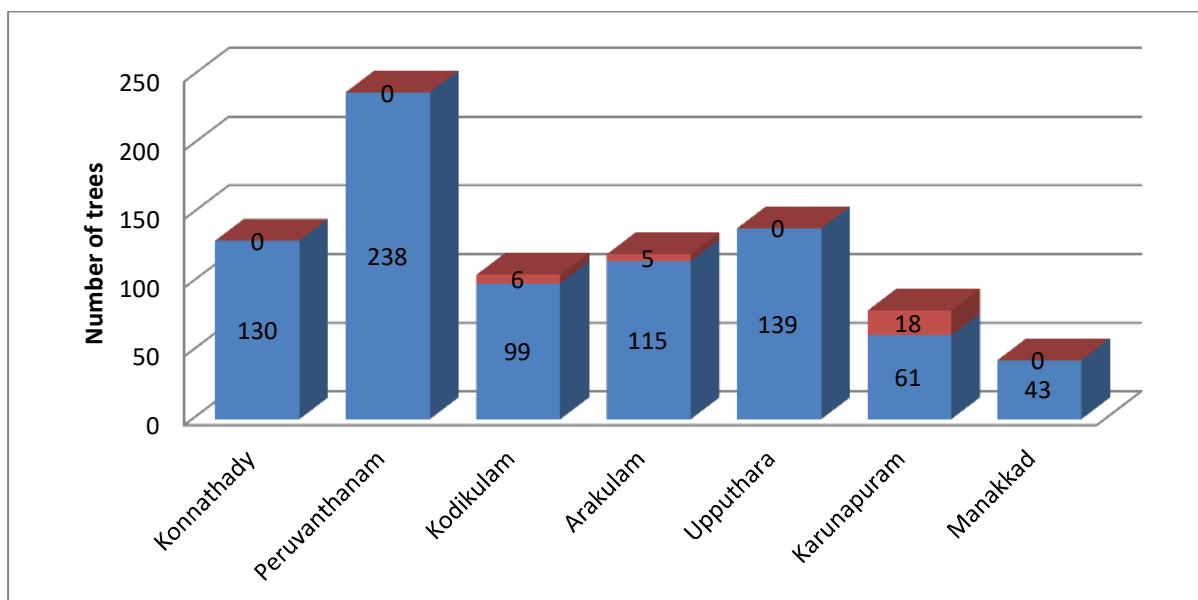

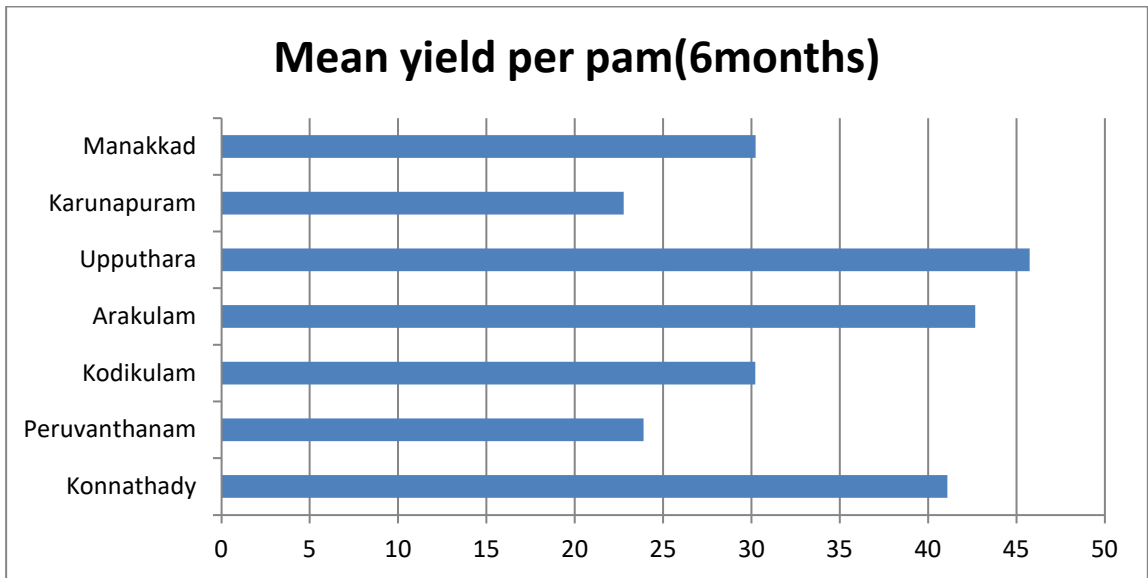
It is observed from the above table that 3.5% of the coconut trees in Idukki district are non-bearing.(majority of the blocks have no non-bearing palms).

The matured coconuts on the trees together with the nuts of varying ages remaining on these 260 palms were observed with the help of trained climbers. From the total number of nuts recorded (5 months old or above) the average number of nuts per tree was estimated. As per the Coconut Board record cumulative percentage of the yield during this period (6 Months) is 59.5. The average yield per palm is $1.68(1+40.5/59.5)$ times the average yield per farm during the six months.

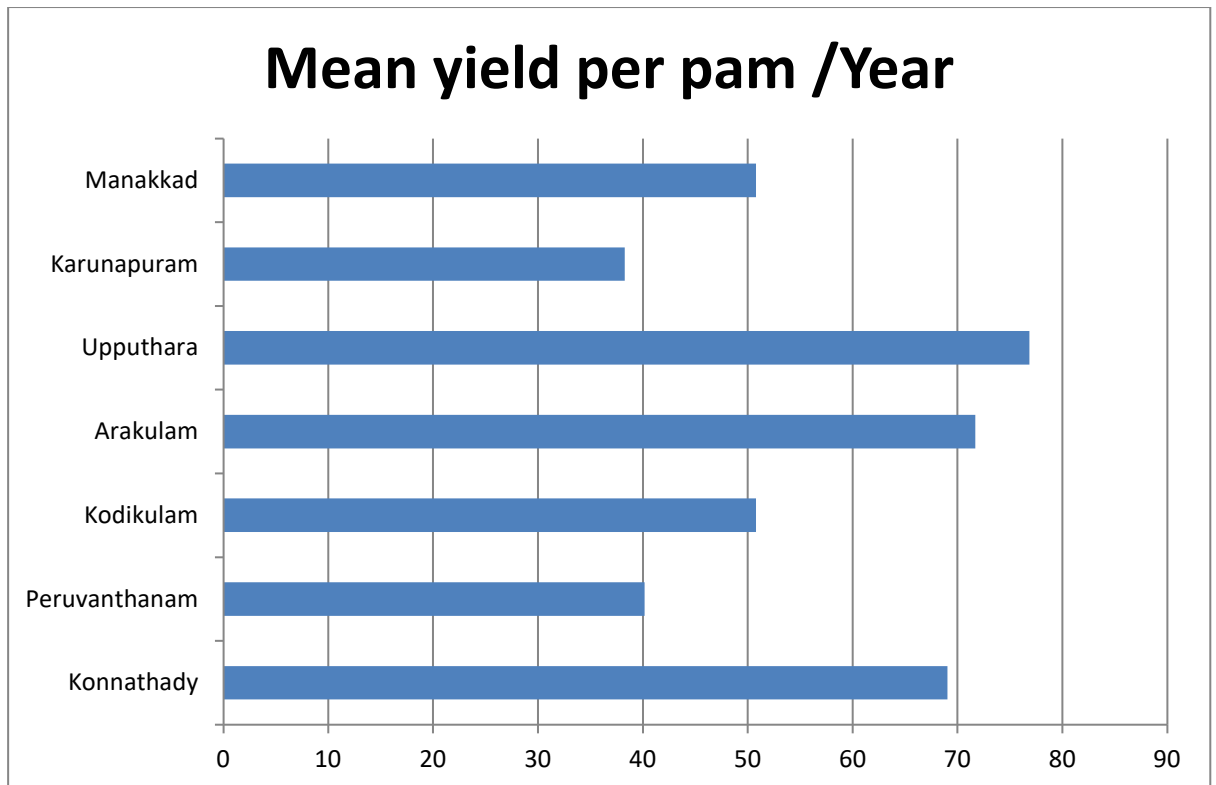
The sampling units (26 Fields) surveyed were practiced to the mixed crops it was almost impossible to estimate the number of coconut plants, coconut plant density and area of cultivation. So we use some prior information regarding this aspect (CDB Auxiliary information).

The following tables give the estimates of average yield per palm for six months and one year for various panchayats in Idukki district.

As per the CDB record the total number of bearing palms is approximately 2096523.

The mean yield per pam is 51.39. The estimated total production of coconuts in Idukki district during the year 2016 is 107740317.

As per the official record the total area under cultivation in Idukki district is approximately 16071 Ha. The estimated productivity of coconut is 6704.

According to my opinion the survey data is not adequate to estimate the area of coconut cultivation, productivity etc. A detailed study of these aspects we may adopt stratification techniques and other sampling techniques (PPS) for getting more accurate and relevant information.



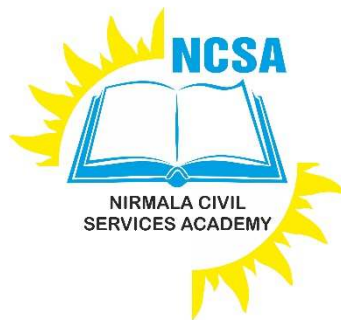

Mushroom Cultivation By The Undergraduate Students From Dept. Of Botany

Brief Report of the Activity:

On 09-06-2014 a group of undergraduate students from Dept. of Botany under the guidance of their teachers attempted to cultivate mushrooms in small scale in the campus. Sr.Dr Tessy Joseph, Associate Professor Dept. of Botany guided them and gave all the instructions. Production was started in the month of June and finished in September. They could produce a total quantity of 19.7 kg of mushrooms in three months and was sold to people living near to the college at reduced price. The extension programme was intended not only as an income generating source for the dept., but also to train students in mushroom cultivation, who can share it among others who are willing to enter such farming methods.

With an aim to develop entrepreneurial skills among the women of the adopted village and to make them self-reliant, a workshop on mushroom cultivation was offered to Kudumbashree units of Avoly.
